AFFIDAVIT

I/We, -----, residing at Add. – ----- Male/Female adult and having our office at -----.
M/s. ----- do hereby state on solemn affirmation as under:

I/We have submitted application for issuance of new PSARA licence / renewal of PSARA licence under the Private Security Agency (Regulation) Act. 2005, for which affidavit is required to be submitted as per section 6 (1) & (2), sub sections (2) of section 9 and section 11 of the said Act,

I/We hereby state that:-

As per section 6(1 &2)

a) I have not been convicted of an offence in connection with promotion formation or management of company (any fraud of misfeasance committed by me in relation to the company), including, an undischarged insolvent; or

b) I have not been convicted by a competent court for an offence, the prescribed punishment for which is imprisonment of not less than two years; or;

c) I am not keeping links with any organization or association which is banned under any law on account of their activities which pose threat to national security or public order or there is information about such a person indulging in activities which are prejudicial to national security or public order ; or

d) I am not dismissed or removed from Government Service on ground of misconduct or moral turpitude.

2. My Firm/Company is registered in India Under Companies Act,/Shops & Establishment Act, and we are the proprietor/partners/directors & citizen of India.

As per Section 9:

(1) I will within six month of obtaining the license commence its activities.

(2) I ensure impetrating of such training and skills to security our security guards and supervisors as may be prescribed.

(3) I will within sixty days from the date of issue of license, employ such number of supervisors as may be prescribed.

(4) I will not employ or engage a person as a supervisor unless he fulfills the conditions specified in sub sections(1) of sections 10.

(5) I will give preference to a person who has experience of serving in the Army, Navy, Air force, any other Armed Forces of the Union or State Police including armed constabularies and Home Guards for a period of not less than three years.

As per Section 11

(1) I will undergo the training as per requirement and submit details of person or persons forming agency & information from time to time to the Controlling Authority regarding any change in their address, change in management and also about any criminal charge made against me or security guards/personnel in the course of their performance of duties of the private security agency or as the case may be employed or engaged by me.

(2) I will impart a required training under sub-section (2) of section 9 and review continuation to the security guards employed or engaged by me.

And I make the aforesaid affidavit solemnly, sincerely and believe the same to be true.
