

THE COMMISSIONER OF POLICE, GREATER MUMBAI

ORDER

(UNDER SECTION 144 OF CRIMINAL PROCEDURE CODE, 1973)

WHEREAS, in exercise of powers, conferred under the Disaster Management Act, 2005, The Government of Maharashtra, has issued notification vide no. DMU/2020/CR 92/DisM-1, Dated : 30th September, 2020 to take certain emergency measures to prevent and contain the spread of COVID-19 virus, and to extend the Lockdown in the entire state of Maharashtra further till midnight of 31st October, 2020 with amendments to operationalize MISSION BEGIN AGAIN for easing of restrictions & phase-wise opening, till 31st October, 2020 for containment of COVID-19 Epidemic in the state of Maharashtra;

2. WHEREAS, vide aforementioned notification, it is further directed that, the National Directives for Covid-19 management as specified in **Annexure-I** shall be followed throughout the State and the activities already allowed and permitted from time to time and as mentioned in **Annexure-II** shall be continued and all earlier orders shall be aligned with the State Govt's order issued on 30th September, 2020 and shall remain in force upto 31st October, 2020;

3. WHEREAS, Govt. of Maharashtra has again issued guidelines regarding Easing of Restrictions & phase-wise opening of Lock-down (MISSION BEGIN AGAIN) vide order No. DMU/2020/CR.92/ DisM-1, Dated : 14th October, 2020 to re-open certain activities in areas outside the Containment Zone and to include certain activities mentioned in **Annexure- II**, in their earlier guidelines issued vide order dated : 30th September, 2020;

4. THEREFORE, I, **Shahaji Umap, Dy. Commissioner of Police (Operations)**, Greater Mumbai and Executive Magistrate, vide powers conferred upon me u/sec 144 of the Criminal Procedure Code, 1973 (Act II of 1974) r/w the Commissioner of Police Greater Mumbai's Order dated 23/12/1959 u/s 10 sub section (2) of the Maharashtra Police Act, 1951 (Mah. Act XXII of 1951), with a view to prevent danger to human life, health or safety, do hereby, promulgate an order under section 144 Cr.PC, in the areas under the control of Commissioner of Police, Greater Mumbai to maintain the Social Distancing Norms (minimum of 6 feet of distance), use of face coverings and to observe the directions issued by The Government of Maharashtra vide Order No.DMU/2020/CR.92/DisM-1, Dated:30/09/2020 and Order No.DMU/2020/CR.92/DisM-1, Dated : 14/10/2020 regarding Easing of Restrictions and Phase-wise opening of Lockdown (MISSION BEGIN AGAIN) and such other orders issued by the competent authorities in this behalf.

5. The Zonal DCsP in emergent /special cases are empowered to grant exemption/permission.

6. This order shall come into force, in the areas under the control of Commissioners of Police, Greater Mumbai, with effect from 00.01 hours on 15/10/2020 and ending at 24.00 hours on 31/10/2020 unless withdrawn earlier.

7. Any person contravening this order shall be punishable under section 188 of the Indian Penal Code, 1860 in addition to penal provisions under Disaster Management Act, 2005 and with other legal provisions as applicable.

8. As the notice can not be served individually on all concerned, the order is hereby passed ex-perte. It shall be published for the information of public, through press, or by affixing copies on the Notice Boards of the police stations, Divisional ACsP, Zonal DCsP.

9. Earlier order u/s 144 CrPC issued by this office on 30th September, 2020 operational till 31st October, 2020 is hereby revoked.
