

**THE COMMISSIONER OF POLICE, GREATER MUMBAI**

**ORDER**

**(UNDER SECTION 144 OF CRIMINAL PROCEDURE CODE, 1973)**

WHEREAS, based on the declaration issued by World Health Organization on 11/03/2020 characterizing the outbreak of COVID-19 a global pandemic and the subsequent notifications issued by Government of India and Government of Maharashtra, under the Epidemic Diseases Act, 1897, and the Disaster Management Act, 2005, it is apprehended that there is **likelihood of spread of the COVID-19 virus through gatherings of persons in public or private areas** and that there is grave danger to human life, health or safety due to the same. The undersigned in the capacity of Executive Magistrate is fully satisfied that there are sufficient reasons / grounds for passing prohibitory orders under Section 144 of Criminal Procedure Code (CrPC), 1973 to ensure that there is no danger to human life, health or safety.

2. WHEREAS Mumbai City continuous to be threatened with the spread of COVID-19, it is considered expedient to issue **prohibitory order for restricting any presence or movement of one or more persons in public places or gathering of any sort anywhere, including religious places** to prevent further spread of the COVID-19 virus in the areas under the control of Commissioner of Police, Greater Mumbai.
3. THEREFORE, I, **Shahaji Umap, Dy. Commissioner of Police(Operations)**, Greater Mumbai and Executive Magistrate, vide powers conferred upon me u/sec 144 of the Criminal Procedure Code, 1973 (Act II of 1974) r/w the Commissioner of Police Greater Mumbai's Order dated 23/12/1959 u/s 10 sub section (2) of the Maharashtra Police Act, 1951 (Mah. Act XXII of 1951), with a view to prevent danger to human life, health or safety, do hereby, promulgate an order under section 144 Cr.PC, in the areas under the control of Commissioner of Police, Greater Mumbai, **prohibiting any presence or movement of one or more persons in public places, or gathering of any sort anywhere, including religious places** subject to the conditions given below :
  - i. **All movement of one or more persons in the areas designated as "Containment Zone" by the Municipal Authorities is prohibited, except for essential activities, supply of essential goods and medical emergencies.**
  - ii. **All movement of one or more persons in the city is prohibited except for Medical Emergencies and for the following exempted entities:**
    - A. Emergency duties;
    - B. Government / Semi-government agencies and their officials on duty;
    - C. Establishment providing Essential services like :
      - a. Food, vegetables, Milk Supplies, Ration and Grocery Stores;
      - b. Hospitals, Medicine, Pharma and related establishments, pathology laboratories, medical/nursing colleges;
      - c. Telephone and internet services;
      - d. Electricity, Petroleum, Oil and Energy related;
      - e. Banking, Stock Exchange, Clearing Corporation, Depositories, Stock Brokers and SEBI registered participants operating through these institutions;
      - f. IT and IT enabled Services and Data Centers providing services for Critical National and International Infrastructure and needed for the above essential and emergency services;

- g. Media;
- h. Ports ;
- i. Services providing Home Delivery of food, groceries and essential commodities
- j. E-commerce activity for essential and non-essential items and materials;
- k. Drinking water supply and maintenance;
- l. Godowns and warehousing related to all of the above.
- m. Trucks/Tempos carrying goods and manpower related to above services.

**iii. All movement of one or more persons in the city for non-essential activities is prohibited, except for:**

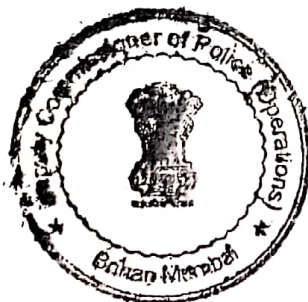
- A. The exempted entities mentioned in Para. 3(ii) and ;
- B. Those activities which are exempted as per the Government of Maharashtra order No. DMU/2020/CR.92/DisM-1, Dated : 29/07/2020, order No. DMU/2020/cr.92/DisM-1 dated : 29/06/2020 issued by the Chairman, State Executive Committee regarding Easing of Restrictions and Phase-wise opening of Lockdown. (MISSION BEGIN AGAIN) and Order No. MGC/A/2916 dated : 20/03/2020 and other such orders issued by the competent authorities for the enforcement of COVID-19 lockdown guidelines,
- C. However, movement of person for non-essential activities mentioned in Para 3(iii)(B), like visit to shops, markets, barber shops, spas, saloons, beauty parlors, outdoor, physical activities etc. shall be permitted within the nearby/neighborhood area only. Long distance travel for non-essential items will not be permitted.

**iv. The Zonal DCsP in emergent / special cases are empowered to grant exemption.**

- 4. It is further directed that the Social Distancing Norms (minimum of 6 feet of distance) shall be followed at all times.
- 5. This order shall come into force, in the areas under the control of Commissioners of Police, Greater Mumbai, with effect **from 00.15 hours on 1/08/2020 and ending at 24.00 hours on 15/08/2020** unless withdrawn earlier.
- 6. Any person contravening this order shall be punishable under section 188 of the Indian Penal Code, 1860.
- 7. **As the notice can not be served individually on all concerned, the order is hereby passed ex-perte. It shall be published for the information of public, through press, or by affixing copies on the Notice Boards of the police stations, Divisional ACsP, Zonal DCsP.**
