3. **All repair works which will be carried out on engine and auxiliaries along with fitment of new equipment should be supported with warranty/Guarantee period.**

Prices quoted should be Total cost inclusive of GST or duties such as Excise duty, Custom duty, Surcharge if any which the supplier is required to pay to the manufacturer should also include in Price. The bills /invoices of material/Goods purchased /received will be processed after the material/Goods are inspected by our Kit Committee and found acceptable. In case the material is rejected the Bidder/Supplier has to collect the material from our Launch Section at his own cost, and replace by a fresh supply. The Bills of an item rejected and not replaced by a fresh supply will not be processed for payment.
