9. Tenderer should submit original Documents i.e. hard copies for verification at the time of bid Opening.
10. Tenderer should quote Final rate (including GST) in BOQ

It is a condition of the contract that all through the currency thereof, the price at which you will supply the stores should not exceed the lowest price charged by you to any customer during the currency of the rate contract and that in the event of the prices going down below the rate contract prices you shall promptly furnish such information to us to enable to amend the contract rates for subsequent supplies.
